
FEDERAL RELIEF FUNDS MEMBER SURVEY KEY FINDINGS


U.S. TRAVEL

Overview Analysis

U.S. Travel fielded a series of surveys to members to gain an understanding of what relief funding has been accessed, the amounts received and intended uses.

- Of those surveyed, nearly nine in 10 (89%) reported receiving some form of federal relief—whether from state & local ARPA funds, PPP or the Employee Retention Tax Credit—**totaling \$487 million.**
- The total average funds received was **\$4.1 million** per organization.





Total Relief Funds Received by Source

State & Local ARPA Funds

- Three in 10 organizations reported receiving ARPA funds from their state or local government, totaling **more than \$260 million.**
- The average amount received was \$7.2 million per organization.
- For some this number was far greater (e.g., Arizona's Office of Tourism received \$100 million).
 - Of those that reported receiving funds, the majority received funds from the State and the top usage was for marketing purposes.




Top State & Local ARPA Funding Usage



Direct Federal Relief

- In addition to the federal funds administered at the state and local level, respondents received **more than \$226 million in direct federal relief**, for an average of **\$2.4 million per organization**.
- Direct federal relief was received through a variety of programs, with PPP being the top source of funding and payroll/staffing being the top use.

Federal Relief Program Spotlight¹

Paycheck Protection Program (PPP)

The Paycheck Protection Program provided forgivable loans of up to \$10 million (1st Draw Loans) or \$2 million (2nd Draw Loans) to small businesses, DMOs, and other entities. The application window for new PPP loans closed on May 31, 2021.

Economic Injury Disaster Loan (EIDL) Program

The Economic Injury Disaster Loan Program provides low-interest loans to eligible employers to cover working capital needs. The application window ends on December 31, 2021.

Number of Recipients: 3.8 million	Average Amount Received: \$76,000

Airport Grants

Through multiple rounds of funding, grants were provided to airports to help prevent, prepare for, and respond to COVID-19—including relief to airport concessionaires.

Amount Enacted: \$20 billion	Amount Distributed: \$15.8 billion
Number of Recipients: 2,000	Average Amount Received: \$1.9 million

Aviation Payroll Support

The Aviation Payroll Support program provided grants to passenger air carriers, cargo air carriers, and aviation contractors for payroll expenses until September 30, 2021.

Amount Enacted: \$62 billion	Amount Distributed: \$59 billion
Number of Recipients: 780	Average Amount Received: \$38 million

Employee Retention Tax Credit (ERTC)

The Employee Retention Tax Credit provided employers with a tax credit to use against payroll taxes, worth up to 70% of eligible compensation, up to \$7,000 per employee per quarter. The bipartisan Infrastructure Investment and Jobs Act (H.R.3684) retroactively moved up the expiration date of the credit to October 1, 2021.
