Dear Leader Thune, Leader Schumer, Speaker Johnson and Leader Jeffries,

On behalf of a broad coalition of organizations and companies representing every sector of the U.S. travel industry, we urge Congress to take immediate action to pay Transportation Security Administration (TSA) officers and protect the frontline workers who safeguard our nation's aviation system and support millions of travelers each day.

Forcing these dedicated officers to work without pay—yet again—is not only unfair, it's reckless. The security of travelers and the country is at stake.

This situation is placing increasing strain on the frontline workforce responsible for protecting millions of travelers. Congress is asking TSA officers to carry out one of the most critical security missions in the federal government while withholding their paychecks and creating more operational pressure.

As shutdowns drag on, the consequences become increasingly visible to the traveling public. Workforce strain and declining morale contribute to staffing shortages that lead to **longer security lines, increased wait times and mounting stress on a system that must operate seamlessly to ensure the safety of the traveling public.**

The 43-day government shutdown cost America's travel industry \$6 billion and impacted more than 6 million flyers. In what should be a historic year for travel, with the 2026 FIFA World Cup and America250 just a few short months away, TSA officers, travel businesses and the flying public cannot afford another day—let alone several weeks or months—of long wait times and increased stress on our nation's aviation security.

Forcing these workers to continue without pay undermines that stability and risks weakening the reliability of a system that protects travelers and billions of dollars in economic activity each day.

We urge Congress to:

- **Ensure TSA is fully funded immediately** so the agency can carry out its critical aviation security mission without disruption.
- **Cosponsor permanent solutions that guarantee pay for essential federal aviation workers during funding lapses**, such as the Keep America Flying Act (S.3031/H.R.5851), the Aviation Funding Stability Act of 2025 (S.1045) and the Aviation Funding Solvency Act (H.R.6086).

Our nation relies on TSA officers to maintain the safety, security and reliability of the aviation system. They continue to show up for the American people every day even when their pay is uncertain.

We urge Congress to immediately fund TSA and enact pay protections for frontline aviation workers during future shutdowns.

Thank you for your leadership and prompt attention to this important matter.
