THE VALUE OF GOVERNMENT **MEETINGS AND TRAVEL**



Government meetings and travel are a proven tool to help federal employees do their jobs more effectively and, in turn, support economic growth and job creation. Cutting these vital functions will only reduce federal efficiency and productivity.

DID YOU KNOW...

- Strong federal travel regulations are already in place to protect against the misuse of taxpayer funds.
- · Meetings and events are a nearly \$500 billion engine for our economy and are vital to American jobs, small business growth and thriving local communities.
- Government meetings supported nearly 300,000 jobs in 2013 and generated \$33.5 billion in travel spending.
- In 2013, meetings and general business travel supported 2.3 million American jobs, add nearly \$267 billion in travel spending and contributed \$42 billion in local, state and federal taxes last year.
- Nine out of 10 federal workers believe that in-person meetings, conferences and other face-to-face events are important for doing their jobs effectively and for advancing the mission of their agencies.

Government Meetings and Travel Boost Efficiency and Productivity:

- Interacting Face-to-Face: Face-to-face interaction is a valuable tool for improving employee training and development, providing efficient taxpayer services, facilitating cross-agency collaboration, and developing private-sector partnerships.
- Transferring Knowledge: Government-wide travel, in-person meetings, conventions, and conferences are critical education platforms, developing advanced skills, enabling workforce training, and facilitating rapid information sharing.
- Advancing An Agency's Mission: Nine out of ten federal workers believe that inperson meetings, conferences, and other face-to-face events are important for doing their jobs effectively and for advancing the mission of their agencies.
- Encouraging Innovation: 84 percent of federal workers agree that America's future innovation and competitiveness require engagement, collaboration, and learning with those inside and outside of government.
