Dear President Trump, Secretary Mnuchin, Leader McConnell, Leader Schumer, Speaker Pelosi, and Leader McCarthy:

Thank you for your efforts to modify the Paycheck Protection Program (PPP) so that it works for the small travel businesses and employees who are struggling to survive this economic downturn. We strongly encourage you to make sure that any legislation to amend the PPP also expands the program's eligibility to include destination marketing organizations (DMOs) of all sizes and structures, which are small business champions and the economic engines of the travel industry. Importantly, if there is a transition to another small enterprise relief program, DMOs will first need access to the PPP.

Our country's DMOs, convention and visitors bureaus (CVBs) and state tourism offices are classified as 501(c) nonprofits or quasi-governmental organizations, which are currently ineligible for the PPP—and most notably the loan forgiveness the program offers—under the CARES Act. They remain ineligible following the most recent PPP funding agreement. As civic-oriented nonprofits, it is even more difficult for them to qualify for other types of SBA loans, denying them the capital they need to keep hard-working Americans employed. A staggering 58% of DMOs have had to lay off or furlough some of their staff and 38% of all DMO travel workers are now out of work. Any shuttering of these organizations jeopardizes the very work that will be integral to our nation's recovery efforts.

DMOs, CVBs and state tourism offices are some of the primary drivers of economic benefits in our communities and the entire United States. It is their efforts that drive customers to local small businesses and support local jobs—placing them at the forefront of economic development for communities nationwide. It is their work that will help restore travel and power America's recovery efforts.

The travel industry has been disproportionately harmed by the economic slowdown caused by COVID-19. Travel-related job losses have surpassed 8 million at its lowest point in May, representing 38% of all jobs losses. The unemployment rate in the travel industry is 51%, which is more than twice the highest unemployment rate during the worst year of the Great Depression. This year, travel spending is expected to decline \$505 billion, representing \$1.2 billion in economic loss—10 times the impact of 9/11. Simply put, the travel industry cannot recover from the greatest economic crisis in our lifetimes without the important work of DMOs. DMOs will promote the businesses and attractions that have safely reopened, provide travelers with information about how to travel safely and keep themselves and our communities healthy during their stay.

Unfortunately, DMOs have seen their funding all but dry up due to the crisis, as most rely on travel-related tax revenues for funding. Unless they can access the payroll and business expense support provided by the PPP, many DMOs will close their doors for good. It must be emphasized that allowing all 501(c) and quasi-governmental DMOs—regardless of size, structure or revenue—access to the PPP will have a positive and powerful ripple effect across the entire country. Therefore, we respectfully and urgently request that any legislation to amend the PPP includes expanded eligibility for all 501(c) and quasi-governmental DMOs so these organizations can secure the critical relief they need to be in the best position to help rebuild our country.
