### THE VISA WAIVER PROGRAM (VWP):

- ✓ Increases security standards
- ✓ Pre-screens travelers against law enforcement databases

- ✓ Promotes legitimate travel and trade to the United States
- Strengthens international partnerships



Through the VWP, pre-screened, pre-approved travelers from participating countries can travel to

the U.S. once approved by elevated security measurements for stays of up to 90 days

## THE U.S. TRAVEL INDUSTRY ENCOURAGES CONGRESS TO SUPPORT THE JOLT ACT TO:

- Rename the Visa Waiver Program to the Secure Travel Partnership to better reflect the security parameters required to participate.
- Expand the Visa Waiver Program to qualified countries that have a commitment to meeting the strict security requirements of the program and have been taking the necessary action.

#### VWP PARTICIPATION REQUIREMENTS

- ✓ A visa-refusal rate below 3 percent
- ✓ An overstay rate below 3 percent
- Compliant electronic passports that meet international aviation security standards
- $\operatorname{\hspace{1.5pt}\checkmark}$  Timely reporting of lost or stolen passports to INTERPOL
- ✓ Agree to information sharing with the U.S. on risky travelers
- Repatriation of citizens removed from the U.S.
- ✓ Undergo initial and continuous security reviews by the U.S.

### WHAT THIS MEANS FOR THOSE TRAVELING THROUGH THE VWP

- Travelers from countries in the VWP undergo advanced security screening against
  multiple law enforcement and security databases **BEFORE** arriving in the U.S., not at the
  time arrival.
- Screening is conducted by the U.S. managed ESTA system, where the Department of Homeland Security can review several law enforcement databases, including:
  - The Terrorist Screen Database
  - Lost and stolen passports data (including INTERPOL's STLD database)
  - · Visa revocations, previous visa refusals and other immigration violations

The U.S. routinely conducts comprehensive reviews of all VWP countries to ensure ongoing compliance. Those who do not meet the program's strict security requirements can lose membership in the program.
